4. **Mandatory Submission:**
Original EMD instrument & Affidavit is to be submitted in the office of the **Deputy Director, Archaeology, Archives and Museums, Kill Gate, Gujari Mahal, Gwalior** on given date and time.
5. **ELIGIBILITY CRITERIA FOR BIDDERS:**
 - (a) At the time of submission of the Bid the bidder should have valid registration with the Government of Madhya Pradesh, PWD in the appropriate class. However, such bidders who are not registered with the Government of Madhya Pradesh, PWD and are eligible for registration can also submit their bids after having applied for registration with appropriate authority.
 - (b) The bidder would be required to have valid registration at the time of signing of the Contract.
 - (c) Failure to sign the contract by the selected bidder within the given time limit, for whatsoever reason, shall result in forfeiture of the earnest money deposit.
6. **Pre-qualification** – a bidder should have experience of executed work during last 5 financial years as below:
 - A. (a) For works, PAC upto Rs. 20 lakh- Certificate of Conservation workshop **or** Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings works, costing not less than 40% of the probable amount of contract;
 - (b) PAC above Rs. 20 lakh & upto Rs. 1 Crore –Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings costing not less than 40% of the probable amount of contract;
 - (c) PAC above Rs. 1 Crore & upto Rs. 2 Crore –Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings costing not less than 30% (Minimum of 40 lacs) of the probable amount of contract and Single Conservation work of not less than 40 lacs;
 - (d) PAC above Rs. 2 Crore –Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings costing not less than 20% (Minimum of 60 lacs) of the probable amount of contract and Single Conservation work of not less than 60 lacs.
- B. Should have (**Applicable for works costing PAC above Rs. 20 lakh only**):

- (a) Turn Over from Civil construction works equal to 75% of PAC amount in any one year during last five years.
- (b) Bid capacity equal or more than the contract amount for which bid is submitted to be evaluated as below (**Applicable for works costing PAC above Rs. 2 Crore only**):

$$\text{Bid Capacity} = (2 A \times B) - C$$

Where:

A = Maximum value of civil engineering works executed in anyone year during the last five year (10% weightage per year shall be given to bring the value of work executed at present price level).

B = Proposed contract period in years (period upto six months will be treated as 0.5 year and more than six months as one year).

C = Amount of work in hand.

7. Technical bid, both Envelope A, and B (original copy of EMD, Affidavit and online bid) will be opened at **Directorate, Archaeology, Archives and Museums, Banganga Marg, Bhopal** in the presence of Contractors or their representative who choose to be present.
8. Financial bid will be opened on the given date and time at **Directorate, Archaeology, Archives and Museums, Banganga Marg, Bhopal**. Any change in the date of financial bid opening will be intimated to the bidders through e-mail only.
9. EMD should be in the form of FDR of any Scheduled commercial bank drawn in favour of **Deputy Director, Archaeology, Archives and Museums, Gwalior** valid for Six months.
10. Financial offer should be submitted on prescribed form available on e-tendering portal.
11. No two firms who have a common partner / proprietor can participate in the same tender.
12. Competent authority reserve the right to reject any or all tenders without assigning any reason thereof.
13. In case of any dispute in connection with this contract, the same shall be a settled as per provisions of clause 12 (GCC) of agreement.
