4. **Mandatory Submission:**
Original EMD instrument & Affidavit is to be submitted in the office of the OFFICE OF THE DY. DIRECTOR, ARCHAEOLOGY, ARCHIVES AND ,MUSEUMS DIVESION – INDORE on given date and time.
5. **ELIGIBILTY CRITERIA FOR BIDDERS:**
 - (a) At the time of submission of the Bid the bidder should have valid registration with the Government of Madhya Pradesh, PWD in the appropriate class. However, such bidders who are not registered with the Government of Madhya Pradesh, PWD and are eligible for registration can also submit their bids after having applied for registration with appropriate authority.
 - (b) The bidder would be required to have valid registration at the time of signing of the Contract.
 - (c) Failure to sign the contract by the selected bidder within the given time limit, for whatsoever reason, shall result in forfeiture of the earnest money deposit.
6. **Pre-qualification** – a bidder should have experience of executed work during last 5 financial years as below:
 - A. (a) For works, PAC upto Rs. 20 lakh- Certificate of Conservation workshop **or** Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings works, costing not less than 40% of the probable amount of contract;
 - (b) PAC above Rs. 20 lakh & upto Rs. 1 Crore –Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings costing not less than 40% of the probable amount of contract;
 - (c) PAC above Rs. 1 Crore & upto Rs. 2 Crore –Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings costing not less than 30% (Minimum of 40 lacs) of the probable amount of contract and Single Conservation work of not less than 40 lacs;

- (d) PAC above Rs. 2 Crore –Experience of having successfully executed Conservation works of Archaeological monuments or Heritage buildings costing not less than 20% (Minimum of 60 lacs) of the probable amount of contract and Single Conservation work of not less than 60 lacs.
- B. Should have (**Applicable for works costing PAC above Rs. 20 lakh only**):
- (a) Turn Over from Civil construction works equal to 75% of PAC amount in any one year during last five years.
